Outline of Medicare Supplement Coverage – Cover Page

This chart shows the benefits included in each of the standard Medicare Supplement plans. Every company must make Plan “A” available. Some plans may not be available in your state.

Basic Benefits

Hospitalization: Part A co-insurance plus coverage for 365 additional days after Medicare benefits end.

Medical Expenses: Part B co-insurance (generally 20% of Medicare-approved expenses), or co-payment for hospital outpatient services. Plans K, L and N require insured to pay a portion of Part B co-insurance or co-payments.

Blood: First three pints of blood each year.

Hospice: Part A co-insurance.

Plans A, B, C, F, & N available for applicants under age 65. Not available for individuals with end stage renal disease.

¹Plans F and G also have a high deductible option which require first paying a plan deductible of \$2,340 before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G does not cover the Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible.



PREMIUM INFORMATION

We, National Guardian Life Insurance Company, can only raise your premium if (a) we change the premium rates which apply to all policies of this form issued by us and inforce in your state; (b) coverage under Medicare changes; or (c) you move to a different Zip Code. We will send you the advance written notice required by your state when we change the premium rates for all policies of this form issued by us and inforce in your state.

There will be a one-time enrollment fee of \$25.00 added to the first premium.

HOUSEHOLD DISCOUNT

If you are applying for a National Guardian Life Insurance Company Standard Plan, you may be eligible for a Household Premium Discount. The discount is available if you currently have a household resident (at least one, no more than three) who is age 50 or older:

- with whom you have continuously resided for the past 12 months or to whom you are either married or with whom you are in a civil union partnership; or
- who has an existing Medicare Supplement policy, or is applying for a policy, with National Guardian Life Insurance Company.

DISCLOSURES

Use this Outline of Coverage to compare benefits and premiums among policies.

READ YOUR POLICY VERY CAREFULLY

This is only an Outline of Coverage, describing your policy's most important features. The policy is your insurance contract. You must read the policy itself to understand all of the rights and duties of both you and your insurance company.

30-DAY RIGHT TO RETURN POLICY

If you are not satisfied with your policy, you may return it to National Guardian Life Insurance Company's, Medicare Supplement Administrative Office, P.O. Box 27248, Salt Lake City, UT 84127-0248. If you send the policy back to us within 30 days after you receive it, we will treat the policy as if it had never been issued and return all of your premiums.

POLICY REPLACEMENT

If you are replacing another health insurance policy, do NOT cancel it until you have actually received your new policy and are sure you want to keep it.

NOTICE

This policy may not fully cover all of your medical costs. Neither National Guardian Life Insurance Company nor its agents are connected with Medicare. This Outline of Coverage does not give all the details of Medicare coverage. Contact your local Social Security Office or consult the Medicare Buyers Guide for more details.

COMPLETE ANSWERS ARE VERY IMPORTANT

When you fill out the application for the new policy, be sure to answer truthfully and completely all questions about your medical and health history. National Guardian Life Insurance Company may cancel your policy and refuse to pay any claims if you leave out or falsify important medical information.

Review the application carefully before you sign it. Be certain that all information has been properly recorded.

RENEWABILITY

This policy is guaranteed renewable for life, as long as premiums are paid on time and the information on your application is correct.
